
# Fine Lines

Jon Detweiler grew up in the Midwest, before moving to Montana. In 1994, he earned a bachelor's degree in Journalism from the University of Montana. After spending time in Asia and Latin America, Jon's work as a photojournalist took him and his wife Donna to Seattle, Washington. Eventually, the dream to train as an artist led Jon and his family to Fort Wayne, Indiana, where he graduated in 2012 from the University of St. Francis' School of Creative Arts, with a Master's Degree in Studio Art. After spending two years in Europe, Jon returned to Fort Wayne and the USF School of Creative Arts, where he now works as the studio technician in ceramics, sculpture, and theatrical set design.
